Dear Richmond Select Board,

Please consider my application for an open spot on the Town of Richmond ARPA committee. I am a former select board member, former water and sewer commissioner, current member of the Planning Commission and current member of the Richmond Climate Action Committee. If appointed to the ARPA committee I will step down from the Planning Commission.

I have been a resident of Richmond for 18 years and work from a home office as a Senior Fellow at Energy Solutions, an energy efficiency consultancy based in Oakland, California. I have worked in the energy efficiency policy and program implementation field since 1984 and am a nationally recognized expert in the engineering and economics of several energy efficient technologies. I am also partners with Jeff Forward in Vermont Independent Energy, a small business that helps Vermont towns acquire solar electricity systems.

The American Rescue Plan Act disbursement of \$1.2 million to Richmond provides a unique opportunity to address some long-term needs and desires in town. However, it is also challenging to figure out how to invest one-time funding in a way that it creates sustained benefits for the community and avoids generating ongoing costs. I endorse the guidance offered by the Vermont League of Cities and Towns in its Planning Framework for Maximum Impact and Best Use of Municipal ARPA funds:

- 1. Prioritize Good Governance
- 2. Leverage ARPA Aid
- 3. Invest in Best Uses for Long-Term Recovery

I helped with the September 10 ARPA committee ice cream social in Riverview Commons and am looking forward to the September 28 meet at CHMS. Through my past work on the Town Plan, I am experienced with community outreach and with compiling and vetting citizen ideas in Richmond. I have been attending forums on the Inflation Reduction Act funds as part of my job and I think there are multiple opportunities to use IRA incentives in concert with ARPA funds to save Richmond residents money. I am generally familiar with Richmond's current infrastructure maintenance needs.

I have an undergraduate degree in engineering and a master's degree in public policy. I am proficient in project budgeting, cost forecasting, and cost-benefit analysis.
