On Tue, May 1, 2018 at 10:26 AM, Montross, Ben <Ben.Montross@vermont.gov> wrote: Hi Kendall, We were going through some of the fluoride data for Richmond and saw a sudden increase in the concentration based on the weekly test you submit to the health department lab. In looking at prior monthly reports I see that the concentration is normally rather low, lower than the target range for dental benefits, so I wanted to check in to see what's going on, what your targets are, and to confirm that the daily target should be about 0.7 mg/L. If you're having issues with the equipment, you can contact Linda Greaves in the health department. Thanks, Ben
